## **TERMS & CONDITIONS**

- 1. The applicant shall get the Reservation/Application from Customer Support Centre by depositing processing fee PKR 5000.
- 2. Booking amount is not refundable, refund will only be entertained after 50% payment from buyer. In case of refund 20% of paid amount will be deducted from the buyer at the time of refund.
- 3. The size and the location of the Plot is tentative and subject to adjust after demarcation/measurement of the Plot at the time of handing over possession.
- 4. 100% dues will have to be cleared till balloting date to participate in balloting, if not then client will not eligible for balloting.
- 5. Installments after due date from the applicant/allottee will only be accepted with surcharge at the rate of 1.5% per month (0.05% per day).
- 6. In case of extra area with any Plot, extra amount will be charged in addition to the total amount.
- 7. For each preferential location, i.e. Corner, Facing Park & Main Boulevard Plot, applicants will pay 10% premium for each category.
- 8. Plot allotted for an applicant shall not be used for any purpose other than applied or meant for.
- 9. No Applicant shall be paid by management any interest/mark up against the amount paid by him in case of any delay in project.
- 10. All registration/mutation charges shall be borne by the allottee along with any other government tax in vogue.
- 11. No construction can be done without the approval of the Designed by the authorities of Green Orchard Lahore.
